POLICE DEPARTMENT REPORT - CHIEF LAKEY

Chief Lakey gave a report on the current Cadets. They are planning to clean up the railroad tracks at the end of Douglas St. He also reported that the Morrow County Commissioners decided to put Morrow County 911 under the Sheriff. In 2025, we will no longer pay for dispatching services to the Sheriff's office.
