FINANCE AND HUMAN RESOURCES - KAY HINES

Hines reported that a discussion was made about the percent increase for employee wages for 2025. Also discussed the cost of employee medical insurance.

Fiscal Officer Davis stated that there is \$120,144.24 in unpaid income taxes at collections. She also reported that there are 62 residents and have not filed for 2022 and 448 that have not filed for 2023

Hines discussed the need for adding into the 2025 budget for paving, fixing the outside restroom at the pool, and replacing the 2006 dump truck. Further discussion about the possibility of hiring a detective for the police department will need to be made for the 2025 budget as well.

The tennis/pickleball and basketball courts will need to be done. Mayor Carver stated that the Village has an old agreement with the Mt. Gilead school stating that we are responsible for the upkeep of these courts. If we do not do this upgrade then school officials will tear up the courts and make parking spots out of them.

Phillips moved and Fraizer seconded to obtain a loan for the tennis, pickleball and basketball resurfacing project not to exceed \$550,000.00 and to pursue a grant if legally possible. Discussion: Clapper asked if we still had plans. Allen stated that we have the plans but will need an updated cost estimate.
