#### **Chief's Summary**

2022 was an interesting and productive year for the Mount Gilead Police Department.

On June 13, two EF-1 tornadoes touched down in Morrow County. One of the tornadoes touched down just North of Mount Gilead. The tornadoes caused a power outage to all the village and nearly the entire county, uprooted trees, and caused extensive damage to buildings, vehicles, and equipment. Law enforcement, Fire, EMS, the Emergency Management Agency, Citizens, and service departments from the villages, townships, state, and utility companies came together and worked hard to provide aid and clear debris. As of December 2022, nearly all the cleanup has been completed. Miraculously, the village, nor the county, suffered any casualties as a result of the tornadoes.

On July 16, the Police and Fire Departments joined forces and organized the first annual Mount Gilead Community Day. The fundraising event was conceived by Mount Gilead Exempted Village School Board Member Vanessa Gingerich. In addition to raising funds, the event strengthened the relationship between law enforcement, firefighters, and the community. With a matching donation by Modern Woodmen, the event raised over \$11,000. The funds were earmarked for the police department's safety town program and the fire department's fire safety house.

On August 15, Mount Gilead Village Council approved a proposal to provide significant raises to the police department staff putting us nearer to the median pay of agencies in surrounding counties with whom we compete with in recruitment and retention of officers. Patrol officers received an approximately 24% increase, supervisors received an approximately 30% increase, and the chief received 18%. Due to the increases, interest in employment with the department and morale have both increased notably. The department is thankful to both village council and previous Mayor Jamie Brucker for their evident support of the department.

On September 7, in collaboration with the Mount Gilead Exempted Village School District, a full-time School Resource Officer position was created and put into place at the start of the school year. The program has proven to be a huge success by both increasing the safety within the schools and building positive, meaningful, and lasting relationships between students, staff, and local law enforcement.

On September 15, the department was certified by the Ohio Collaborative Community-Police Advisory Board. This certification indicates that department policies, procedures, and practices are in compliance with state and federal directives. Certification also gives access to some grant opportunities. The Mount Gilead Police Department was selected as the agency of the month for December.

My goals for 2023 continues to be training that aligns with the department mission and supports each individual officer to better serve our community. We will continue to provide professional and proactive law enforcement services to the citizens and visitors of the Village of Mount Gilead.

On May 4, Officer Chase Beekman was promoted to the rank of Sergeant.


On May 25, Officer Maiya Belcher resigned.

## Patrol Operations Summary

In 2022, MGPD officers responded to 1,859 calls for service, investigated 367 reports, handled 72 crashes, made 1,299 traffic stops, issued 950 warnings, conducted 4,567 foot-patrols, and issued 686 charges to 564 persons. The youngest person charged was 14 and the oldest person charged was 75.

In addition to patrolling the Village, officers carried out many valuable community service functions such as: 188 money escorts, 128 vehicle lockouts, 58 Fire Department and Emergency Medical Service assists, and attended numerous public relations events.

A call for service is anytime an officer is requested for help.

A report is taken whenever there is a criminal offense requiring investigation or documentation or a death.


A crash report is taken for crashes that occurred on the roadway or crashes on private property resulting in injury or significant property damage.

A traffic stop is anytime an officer contacts a motorist for a violation of law.

A foot-patrol is anytime an officer is out of the car to check a business or residence or interacting with citizens for no reason other than to socialize.

A charge is a citation, complaint, or warrant issued for a criminal offense.


# Patrol Operations Zone Map




The Village of Mount Gilead is divided into 5 "Zones" for statistics and tracking purposes.


- **Zone 1 = North of High Street, West of Main Street**



The department currently has one Canine Officer, K9 Nik.


He is handled by Captain Cronenwett.

Note: K9 cruiser was out of service 7/4-8/12 and K9 handler was out of service for majority of December.






